For the purpose of federal financial aid, federal guidelines permit financial aid administrators to determine that a student is a homeless unaccompanied youth, self-supporting or at risk for homelessness. This form is intended to verify the student's status as reported on the 2009/10 Free Application for Federal Student Aid (FAFSA). A student who reported being homeless or at risk of being homelessness must submit the following documentation.

- A detailed letter of appeal stating your situation.
- Submit three original letters of verification from either a:
 - High school or school district homeless liaison;
 - Director of emergency shelter program funded by U. S. Department of Housing and Urban Development (HUD);
 - Director of a runaway or homeless youth basic center or transitional living program;
 - HELP Agency; or
 - Social Services Case Worker
- A completed Free Application for Federal Student Aid (FAFSA) on file.

*The verification letters are attached.

I certify that this information is true and complete. I understand that failure to provide the above supporting documentation will affect my status to receive federal financial aid. If you purposely give false or misleading information, you may be fined up to \$20,000, sent to prison, or both.

Frequently Asked Questions

Who are Unaccompanied Homeless Youth?

Unaccompanied homeless youth are young people who lack safe, stable housing and who are not in the care of a parent or guardian. They may have run away from home or been forced to leave by their parents. Unaccompanied youth live in a variety of temporary situations, including shelters, the homes of friends or relatives, cars, campgrounds, public parks, abandoned buildings, motels, and bus or train stations.

Generally, youth leave home due to severe dysfunction in their families, including circumstances that put their safety and well-being at risk. Unfortunately, physical and sexual abuse in the home is common. Unaccompanied youth do not receive financial support from their parents and do not have access to parental information.

Who are School District Liaisons?

Every school district is required to designate a liaison for students experiencing homelessness. Homeless liaisons have a number of legal responsibilities, including identifying youth who meet the definition of homeless and are unaccompanied. For more information see:
