Learning and teaching in the 21<sup>st</sup> Century requires high quality teachers who are able to support the learning process. *Preparing Teachers for a Changing World* (Linda Darling Hammond) and others identified four lenses for understanding the learning process and the teaching that supports it:

- 1. Learning is knowledge centered. Teachers need knowledge of learners, of curriculum and subject area content and of teaching.
- 2. Learning is learner centered. Teachers must be able to interact with students based on students' prior knowledge.
- 3. Learning is assessment centered. Teachers must be able to assess knowledge and track progress.
- 4. Learning is community centered. Teachers must be able to draw on non-school learning since only 14% of a child's time is spent in school.

The need to identify talented people to fulfill the teaching role has led to a reliance on testing as the gateway to the training required for the profession. Many who display appropriate dispositions of effective teachers are hampered in their quest to become teachers by inadequacies in their own education. Many potentially effective teachers are thus denied entry to the profession. Grambling State University seeks to provide a pathway that enables this pool of potential teachers to meet the criteria for admission to teacher preparation programs.

The U. S. Census Bureau predicts that by 2010 the racial composition of schools will be fiftynine percent Black. As research indicates that ethnic minority children respond best to teachers of the same ethnicity, increasing the pool of minority teachers is essential. This year the grant will continue to focus on providing intense support for strengthening study and test taking skills with an increased emphasis on putting forth maximum efforts to succeed in the development of knowledge and skills needed to teach, and also to experience the results of success based on increased efforts.

The strengthening efforts include providing extensive resources to support activities to refine technological skills, activities that stimulate increased individual effort, and services that encourage and increase persistence. Support in these areas is expected to increase completion of teacher education programs leading to certification.
