In-State Residency Agreement
Fall 2009, Spring 2010 and Summer 2010

Residency Guidelines

For tuition purposes, **new students** from other states (U.S. citizens) may be considered residents of Louisiana when registering for admittance to Grambling State University provided they satisfy the following minimum criteria:

1. Students must **first** satisfy the admission requirements of the institution.
2. Additional minimum admission criteria include
 - **First-time freshmen:**
 - a) ACT of 17 (or SAT of 820) and final HS un-weighted GPA of 2.5 on 4.0 scale, or
 - b) ACT of 18 (or SAT of 860) and final HS un-weighted GPA of 2.3 on 4.0 scale, or
 - c) ACT of 19 (or SAT of 900) and final HS un-weighted GPA of 2.0 on 4.0 scale.
 - **Transfer students** (who have completed at least 12 credits of college level work):
 - a) Cumulative GPA of 2.5 on college level work, and
 - b) Have no need for developmental course work, and
 - c) Be eligible to return to previous institution.
3. Students must earn a minimum of 12 credit hours each semester to be eligible to continue the residency status.
4. Students may remain eligible to retain residency as long as they maintain satisfactory academic progress as defined by Grambling State University (which includes a minimum 2.0 GPA each semester).
5. If student fails to enroll or drop below 12 credit hours for any semester, residency will be forfeited for subsequent semesters.

Statement of Understanding

1. I understand that my final high school transcript must show the required GPA for residency status.
2. I understand that my residency status is based on information provided on my application for admission. If any information is not accurate or if any information changes, my residency status may change.
3. I understand that I must earn at least 12 credit hours each semester to retain my residency status.
4. I understand that remaining out of school for summer sessions does not affect my residency status for subsequent semesters; neither does part-time **summer** enrollment.
5. I understand that once I fail to meet the requirements to retain residency, I will not be eligible for residency for subsequent semesters.
6. I understand that once final grades are posted, my residency status will be evaluated each semester to determine if the criteria have been met. The credit hours and GPA requirements must be met in order to retain residency. I will be notified by mail or email as soon as it is determined that the criteria have not been met. **Failure to maintain current mailing or email address will result in notification of residency status being delayed.**
7. **If pre-registration has taken place, I understand that my student account will be adjusted to reflect loss of residency status.**
8. **I understand that I must sign and return this agreement in order to receive my residency status. (Mail to: Office of Admissions – 403 Main St.; P O Box 4200 – Grambling, LA 71245)**
