# EXPLORING LONGEVITY AMONG VETERANS IN RURAL BLACK CEMETERIES IN NORTHERN LOUISIANA

### **ABSTRACT**

Using tombstones, monuments, and grave markers, the first phase of this exploratory study investigates the longevity among veterans born in the late 1800s and the early twentieth century who are buried in rural black cemeteries in a academic community in northern Louisiana. The second phase will compare longevity findings from the rural black academic community with findings from a non-rural academic communityspecifically-rural farm/plantation. The third phase will be gracial comparison using rural-white cemeteries. An attempt will an understanding and explanation of the findings of the study.

## RESEARCH QUESTIONS

- Did veterans born in the late 1800s, 1900s, 1920s, 1940s, and other decades live beyond their life expectancy?
- Did the studied veterans live to be senior saints, pre-centenarians, centenarians, and super centenarians?
- Does race differences exist in living beyond or within the predicted life expectancy?

#### RELEVANT BACKGROUND

- Studies have shown that in the late 1800's life expectancy was short. Majority of the male species lived up to 40 years, while women lived up to 50 years during the 1800's.
- ♦ However, in the early 20<sup>th</sup> century the life expectancy rate was around 50 years old and today its around 77-81 years of age.
- Studies have also shown lifetime earnings to be associated with longevity (Gaudecker & Scholz 2006).
- Changes in pension laws have been documented to have a significant effect on life expectancy. For example, life expectancy for veterans who received old-aged pensions increased by .5 years and 2.7 years (Salm 2007).
- Salm (2007) found that the effect of veteran pensions on longevity was large across wealth groups and the size of the city.

### **Defining Longevity**

 Longevity is defined as long life; it is sometimes used as a synonym for life expectancy

For the purpose of this study, four longevity groups are identified.

- Senior Saint has lived to be 70 years or more.
- Pre-Centenarian has lived to be 90-99.
- Centenarian has lived to the age of 100 years or more.
- Super- Centenarian has lived to be the age of 110 or more.

#### Methods

- ♦ Students at Grambling in training for the social research club were instructed to gather data from tombstones pertaining to the date of death and birth of veterans born in the late 1800s to present time.
- Other relevant information on the tombstones was also obtained.
- Ethnographic research tools included: Notebooks, pencils, cameras, pocket cameras, cell phones, and digital cameras.
- ♦ Informants /key consultants were used to provide information about some veterans buried in the cemeteries of focus.

### CONCLUDING STATEMENT

- ❖The Veterans in our research lived beyond what was considered the life expectancy during their time.
- ❖ The life expectancy for black Veterans who were born in the early 1900's, were expected to die around their early 30's through their late 40's.
- ❖For example, in Table I, their life expectancy was 42 years and Table II, life expectancy was 46 years through 53 years.

## FUTURE DIRECTION OF THE RESEARCH

- Racial comparison of data from select exclusive white and black cemeteries for veterans buried in rural settings is still in progress.
- Interpretation of the findings from the rural black and white cemeteries.
- Inclusion of additional rural and non-rural cemeteries.
