EVALUATION OF TRANSFER CREDITS POLICY

I. PURPOSE/OBJECTIVE

To ensure that transcripts and prior learning assessments of all students who meet the criteria for admission to Grambling State University are evaluated properly and consistent with best practices in records and registration.

II. STATEMENT OF POLICY

Courses on the transcripts from a regionally accredited post-secondary institution which meet the established criteria are accepted and reflected on the academic transcript according to the same policies and procedures in place for students at Grambling State University. Transfer courses accepted for credit are not necessarily used toward degree requirements.

- A. All grades are transferrable to calculate a cumulative grade point average.
- B. Transfer courses in the major discipline will be evaluated by the respective academic advisor and/or dean to determine which courses will be accepted towards degree requirements. The academic advisor or dean will also determine which transfer credits are equivalent to Grambling State University courses from regionally accredited institutions. All course substitutions will be submitted on the appropriate form and forwarded to the Office of the Registrar to be articulated on the student's academic transcript within two (2) working days of evaluation by the academic department.
- C. The grade point average(s) earned at the other accredited post-secondary institutions will be recorded on the transcript with all courses taken and the grades that were earned. However, the grade point average(s) earned at other accredited postsecondary institutions will not be used in determining the institutional grade point average at Grambling State University.
- D. Transcripts from colleges and universities outside the United States of America are evaluated by World Education Services (WES) or an agency of equivalent standing. WES is a non-profit organization specializing in foreign credential evaluations. The evaluation is used to determine admission, course equivalency, and grade point average. The student will be responsible for all fees associated the evaluation.

- E. The university prior learning assessments shall include:
 - 1. Advanced Placement (AP) Exams
 - 2. American Council on Education (ACE) Credit
 - 3. College Level Examination (CLEP) Programs
 - 4. Grambling State University Credit by Examination
 - 5. International Baccalaureate (IB).
- F. Credit for prior learning may apply toward various parts of a student's academic degree as outlined in the curriculum
- G. The number of credit hours that are applied toward graduation through prior learning assessment is governed by the graduation requirements of the academic major.
- H. Credits for prior learning credits shall be entered on the student's academic record by the Registrar's Office by the end of the term in which the assessment took place or the request for prior learning assessment credit was approved.
- I. The Academic Deans, Registrar, Director of Testing Assessment, and Provost/Vice President will convene when there are revisions by College Board.

III. DEFINITION

Prior Learning Assessment (PLA) is the process of earning college level credit outside the traditional academic environment. It offers students the opportunity to earn college credit for knowledge and skills attained through military training, independent study, and Advanced Placement/Dual Enrollment, College Level Examination Program and proficiency exams.
